NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On July 1, 2015, Tucson Electric Power Company ("TEP" and "Company") filed with the Arizona Corporation Commission ("Commission") its 2016 Renewable Energy Standard and Tariff ("REST") Implementation Plan ("Plan") in compliance with A.A.C. R14-2-1801 *et seq.*

On October 5, 2015, the Residential Utility Consumer Office ("RUCO") filed an Application to Intervene in this matter.

RUCO was established by the enactment of A.R.S. §40-461 *et seq.*, for the purpose of representing residential utility consumers in matters before the Commission concerning public service corporations. RUCO asserts that residential utility consumers will be directly and substantially affected by the Commission's Order in this matter.

No party objected to RUCO's intervention.
