CORRECTED SERVICE AREA MAP**


On October 2, 2015 Administrative Law Judge Sasha Paternoster docketed her recommendation, in the form of an Opinion and Order, in the above-captioned dockets.

The Commission's Utilities Division ("Staff") has reviewed the service area map that was attached as Exhibit A to the Recommendation, and determined that Exhibit A should be revised. Specifically, after further review of Exhibit A, that it does not include the area described as Ajo Mile Post 18; the legal description for which is contained in the final page of the Recommendation immediately following Exhibit A. Staff believes that the Ajo Mile 18 was not picked up on a photo copy of the service area map, but it should be included on Exhibit A. In all other respects, Exhibit A, as attached to the Recommendation, was correct.

Accordingly, Staff has attached a revised service area map to this Notice, and requests that this revised service area map be substituted, in its entirety, for Exhibit A to the Recommendation.

1 Staff has contacted counsel for each of the other parties in this matter, and is authorized to inform the  
2 Commission that none of the parties object to Staff's filing of its revised service area map.


