REQUEST FOR TRANSFER

On September 28, 2015, Arroyo Water Company, Inc. ("Arroyo" or "Company") filed an application with the Arizona Corporation Commission ("Commission") for approval of an emergency rate increase.

On the same date, Arroyo filed an Application for Approval of the Sale of Assets and/or Transfer of Certificate of Convenience and Necessity in Docket No. W-02593A-15-0340.

Arroyo is operating under the Certificate of Convenience and Necessity issued in Decision No. 70206 in Docket No. W-04286A-04-0774. Although the Company appears to have operated under both the names "Arroyo Water Company, Inc." and "Kacy Parker dba Arroyo Water Company, Inc.," it appears that since the issuance of Decision No. 70206, the Company has intended to operate as a Corporation rather than as an individual or sole proprietorship. Further, a review of the decision would support that position. Yet the caption in that docket still reads "Kacy Parker dba Arroyo Water Company, Inc."


Because the Company operates pursuant to the CC&N issued in Docket No. W-04286A, Staff believes that this and all further proceedings regarding this entity should also be addressed in the Docket containing that prefix. Further, the caption of that Docket should be changed to reflect that the Company name is "Arroyo Water Company, Inc."
