NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On May 5, 2015, Sulphur Springs Valley Electric Cooperative, Inc. ("SSVEC" or "Company") filed an Application with the Arizona Corporation Commission ("Commission") for a rate increase. By Procedural Order dated October 6, 2015, the matter was set for hearing to commence on May 17, 2016, and other procedural guidelines were established.

On October 6, 2015, the Arizona Solar Deployment Alliance ("ASDA") filed an Application for Leave to Intervene in this docket. ASDA is a non-profit organization that is comprised of solar companies that install solar arrays in the Company's service area.




