PROCEDURAL ORDER

BY THE COMMISSION:

On May 7, 2015, Parker Lakeview Estates Homeowner's Association, Inc. d/b/a Parker Springs Water Company ("Parker" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a permanent rate increase ("Application").

On June 4, 2015, the Commission's Utilities Division ("Staff") issued its Sufficiency Letter indicating that Parker's Application was sufficient under the Arizona Administrative Code, and classified the Company as a Class E public service utility. Staff stated the Decision in the matter should be rendered on or before October 5, 2015, barring any extraordinary circumstances.

Staff filed its Staff Report in this docket on August 3, 2015.

Due to scheduling conflicts, the time clock in this matter must be extended to October 31, 2015. Parker and Staff did not object to the extension.

IT IS THEREFORE ORDERED that the **time clock in this matter is extended to October 31, 2015.**


