

At its Open Meeting on July 7, 2015, the Arizona Corporation Commission approved the following rates and charges for Greenthaven Sewer Company, Inc. in its application filed on September 3, 2014. Per Decision No. 75160, the rates and charges herein will be effective for all service provided on or after August 1, 2015.

The recent approval will increase the monthly bill for a residential customer by \$20.40, from \$12.25 to \$32.65, or 166.53 percent.

Dear Greenehaven Water Company Customer:

At its Open Meeting on July 7, 2015, the Arizona Corporation Commission approved the following rates and charges for Greenehaven Water Company, Inc. in its application filed on September 3, 2014. Per Decision No. 75161, the rates and charges herein will be effective for all service provided on or after August 1, 2015.

The recent approval will increase the monthly bill for a residential customer with a 5/8 x 3/4 inch meter and average water usage of 5,033 a total of \$6.73, from \$15.05 to \$21.78, or 44.72 percent. A customer with median water usage of 2,934 per month would experience a \$4.93 increase, from \$11.90 to \$16.83, or 41.45 percent.
