We have 4- horses, 6-goats, 5-pigs (+expected piglets) 12-dogs (3 are fosters) 11-cats (3 are fosters) 34 hens & roosters, 1-snake, that requires a lot of water!

We have 3 horses that share a 2500 gal holding tank & during the summer haul 2-4 separate loads of 500 gal each. Our cost for 1000 gal 12.00 from Roadrunner Transit would cost us \$600.00 a month!

Our family needs water to survive and cannot afford \$36.00 per day to have water hauled.

Our live stock would die w/out readily available water. In turn we would lose our fresh eggs & potential fresh milk.

Shutting the standpipe down would drop the value of our home substantially.

We have the right to haul our own water & should not be forced to pay a hauling company, if you close the standpipe then water needs to be run to each home like all other houses.

Customer stated that there are (6) in the household and (73) animals.
