**REQUEST FOR AN EXTENSION OF TIME
TO FILE STAFF REPORT**

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") hereby requests an extension of time to file its Staff Report.

On July 8, 2015 the Administrative Law Judge issued a procedural order outlining the schedule for the application for a permanent rate increase and the application for approval of financing for Tierra Buena Water Company, Inc. ("Company or Tierra Buena"). It was ordered that Staff file its Staff Report on or before August 18, 2015.

Staff would request an extension of two (2) days to August 20, 2015. The Company would still file any objections by September 1, 2015. This will allow staff sufficient time to properly review its Staff Report and still provide the Company with twelve (12) days to respond.

Staff has spoken with the Company and they have no objections to the extension and believe they will still have sufficient time to respond should they have any objections to the Staff Report.
