RE: CEC Annual Certification Letter

Ladies and Gentlemen:

First Solar Development, LLC, on behalf of its wholly owned subsidiary Sun Streams, LLC, hereby submits its annual self-certification letter for the Sun Streams Gen-tie Project's Certificate of Environmental Compatibility issued by the Arizona Corporation Commission in Docket No. L-00000XX-14-0120-00168 (the "CEC"). The following is a report on the progress of each condition contained in the CEC:

1. Sun Streams certifies that Conditions 1 through 8 of the CEC are not yet due or applicable, as construction of the Project has not commenced.
2. Condition 9 requires that a sign be placed on the Project site advising (a) that the site has been approved for the construction of Project facilities; (b) the expected date of completion of the Project facilities; (c) a phone number for public information regarding the Project; (d) the name of the Project; and (e) the website of the Project.

3. Condition 10 requires that a copy of this self-certification letter be submitted to the Arizona Attorney General and the Arizona Governor's Office of Energy Policy. Sun Streams, LLC certifies that it has complied with Condition 10.
4. Condition 11 requires that a copy of the CEC be provided to Maricopa County, the State Historic Preservation Office, and the Arizona Game and Fish Department. Sun Streams, LLC certifies that it has complied with Condition 11.
