

**MOTION FOR EXTENSION OF

23 Tierra Buena Water Company, Inc. ("Company") hereby files a motion for an
24 extension of time to file its response to the Staff report in this matter. The Company
25 respectfully requests a three-day extension, making its comments due on Friday,
26 September 4, 2015.

1 The extension is needed for several reasons. First, the Staff Report is lengthy and
2 complex, dealing with both rates and project financing simultaneously. Consequently,
3 the analysis and drafting of comments is going to take more than seven business days to
4 complete. In addition, counsel for the Company had two rate cases and comments to a
5 recommended opinion and order due on or about September 1, 2015. The Company's
6 accountant also was involved in some of this work. The principal managers of the
7 Company were also unavailable last week.

10 There are no further replies or responses scheduled in this matter, therefore, the
11 other party in this case, Staff, will suffer no prejudice if this motion is granted. The
12 Company has informed Staff regarding this extension request and Staff has no objection
13 to the extension. Therefore, the Company requests that it be allowed to file its
14 comments to the Staff Report on or before Friday September 4, 2015.
