MOTION FOR
EXTENSION OF TIME

Global Water - Picacho Cove Utilities Company ("Picacho Utilities") and Global Water - Picacho Cove Water Company ("Picacho Water")(collectively "Picacho") respectfully request an extension of time for various deadlines due on October 30, 2015 under in Decision No. 73618 (Dec. 12, 2012). That decision requires Picacho to file copies of:

- (1) Picacho Utilities' "General Permits for the collection system for Phase 1 of the initial phase of the Picacho Citrus and Langley Picacho Views developments";
- (2) Picacho Utilities' Aquifer Protection Permit ("APP");
- (3) Picacho Water's Approval to Construct for Phase 1 of the initial phase of the Picacho Citrus and Langley Picacho Views developments;
- (4) Picacho Water's (a) Approval to Construct for an arsenic treatment system, or (b) ADEQ-approved blending plan; and
- (5) Picacho Water's Designation of Assured Water Supply ("DAWS").

This is the third extension of time in this docket. These compliance requirements were originally specified in Decision No. 70312 (April 24, 2008), and extensions of time were granted in Decision Nos. 71900 (Sept. 28, 2010) and Decision No. 73618 (Dec. 12, 2012). Picacho regrets having to

1 seek a third extension of time. However, the extension of time is needed because the development
2 timetable for the two properties in the CC&N has been delayed again.


3 The CC&N area approved in this docket is located in the Greater Eloy, Arizona area. This
4 portion of Pinal County was particularly hard hit by the economic downturn that began in 2008.

5 Picacho has requested renewed request for service letters from the landowners of the two
6 properties, Picacho Citrus 930, LLC and LLF Picacho Citrus, LLC and Langley Picacho Views
7 160, LLC. These landowners supported Picacho's original application for a CC&N as well as
8 Picacho's most recent motions for extension of time. Picacho will file the renewed request for
9 service letters with the Commission when they are received.

10 Accordingly, Picacho requests that the Commission grant an extension of the due dates for
11 items (1) through (5) above, until October 30, 2018.
