PROCEDURAL ORDER
(Granting Intervention)

BY THE COMMISSION:

On July 10, 2015, Liberty Utilities (Litchfield Park Water and Sewer), Corp. ("Liberty") filed with the Arizona Corporation Commission ("Commission"), an application requesting that the Commission approve an extension of its current Certificate of Convenience and Necessity ("CC&N") to provide wastewater utility service to include the Zanjero Trails development in Maricopa County, Arizona.

On July 28, 2015, Maricopa County Municipal Water Conservation District Number One ("MWD") filed its Application to Intervene.

There has been no objection filed to MWD's intervention request, and accordingly, MWD should be granted intervention.

IT IS THEREFORE ORDERED that MWD is hereby granted intervention.

IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Arizona Supreme Court Rule 42). Representation before the Commission includes the obligation to appear at all hearings, procedural conferences, and Open Meetings for which the matter is scheduled for discussion, unless counsel has previously been granted permission to withdraw by the Administrative Law Judge or Commission.
