BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the
Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. In Decision No. 59692 (June 5, 1996), the Arizona Corporation Commission
("Commission") granted Robert M. Wellings d/b/a American General Payphone ("AGP" or
"Company") a Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay
telephone ("COPT") telecommunication services in Arizona.

2. On June 23, 2015, AGP filed an application with the Commission requesting approval
to cancel its CC&N to provide COPT services in Arizona. AGP's application stated that the
Company is no longer, or never did, provide COPT service in Arizona; that the Company waives its
right to notice and a hearing; and that Mr. Robert Wellings was authorized by the Company to file the
application.

3. On July 23, 2015, the Commission's Utilities Division ("Staff") filed a Memorandum
recommending approval of RLC's application to cancel its CC&N. Staff states that the
Commission's Corporations Division reports no record for the Company as it is not incorporated in

1 Arizona; the Commission's Consumer Services Section reports that the Company has not been the
2 subject of any complaints, opinions, or inquiries; and the Company's last Utilities Annual Report was
3 submitted in 2010. Staff recommends approval of the Company's application and that upon
4 cancellation of the its CC&N, RLC will no longer be authorized to provide COPT
5 telecommunications services in Arizona, or be subject to the requirements set forth in Decision No.
6 59692 (June 5, 1996).

7 4. Staff's recommendations are reasonable and should be adopted.

8 **CONCLUSIONS OF LAW**

9 1. Robert M. Wellings d/b/a American General Payphone is a public service corporation
10 within the meaning of Article XV of the Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

11 2. The Commission has jurisdiction over Robert M. Wellings d/b/a American General
12 Payphone and the subject matter of the application.

13 3. The cancellation of Robert M. Wellings d/b/a American General Payphone's CC&N
14 to provide customer owned pay telephone telecommunication services in Arizona is in the public
15 interest.

16 4. Robert M. Wellings d/b/a American General Payphone waives its right to notice and a
17 hearing in this matter.

18 5. Staff's recommendations are reasonable and should be adopted.



ORDER






