**ORDER AMENDING

6 **IT IS ORDERED:**


7 The Applicant and all other parties and potential parties desiring to file a

11 Until the legal issue referred to in Paragraph 31 of the Procedural Order
12 is decided, the Applicant will cooperate in providing data and information
13 relating to the Application as requested by all parties and potential parties.

14 In all other respects, the Procedural Order of September 11, 2015
15 remains in full force and effect.

16 **IT IS FURTHER ORDERED**, the Chairman may amend or waive any
17 portion of this or any other Procedural Order filed in this matter by subsequent
18 Procedural Order, by ruling at a pre-hearing conference, or at a hearing.


