**BY THE COMMISSION:**

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission (“Commission”) finds, concludes, and orders that:

**FINDINGS OF FACT**

1. On September 16, 2015, the Commission issued Decision No. 75271, approving rate increases for Baca Float Water Company, Inc.’s Water Division and Wastewater Division.
2. Decision No. 75271 contained a typographical error in the Water Division’s Service Line and Meter Installation Charges for a 3/4-inch Meter delineated on pages 6 and 13. The total charge for the 3/4-inch Meter is listed as \$700.00. The correct amount is \$710.00.
3. Decision No. 75271 should be revised to reflect the correct total Service Line and Meter Installation Charges for a 3/4-inch Meter of \$710.

**CONCLUSIONS OF LAW**

1. Baca Float Water Company, Inc. is a public service corporation within the meaning of Article XV of the Arizona Constitution.
