**CLEAR SPRINGS' APPLICATION
TO AMEND DECISION NO. 74037**

23 As requested by the Arizona Corporation Commission ("Commission") staff, and
24 pursuant to A.R.S. § 40-252, Clear Springs Utility Co., Inc. ("Company" or "Clear
25 Springs") files this motion to amend Decision No. 74037 ("Decision") by modifying
26 certain dates relating to financing proposed improvements.


27 Recently, in Decision No. 75232 the Commission extended the financing time
28 deadlines contained in Decision No. 74037. During the loan approval process at WIFA,
Commission Staff informed WIFA and the Company that it believes another deadline

1 must be extended. The Decision requires the Company to file Approvals of Construction
2 for the improvements by no later than July 1, 2015. Based upon Staff's position, WIFA
3 will not approve the loan financing until this deadline is extended. While the Company
4 does not agree that this deadline is relevant to the financing approval at this point, the
5 Company is willing to cooperate.

6 Therefore, the Company requests that the Commission extend the deadlines for
7 filing the Approvals of Construction. The Company proposes that the Commission
8 extend the deadline for debt authorization to March 31, 2016. The Company further
9 requests that the deadline for completing the improvements and filing the Approvals of
10 Construction be extended until August 31, 2017. These proposed deadlines provide the
11 Company reasonable time to enter into a WIFA loan and make the improvements
12 described herein.
