**REQUEST FOR ADDITIONAL  
TIME TO CONCLUDE  
SETTLEMENT DISCUSSIONS**

21 Utility Source, L.L.C. ("Company"), hereby moves the court for additional time to  
22 settle the rate case matters. The parties need additional time to resolve issues primarily  
23 relating to how the revenue requirement is being met. Put another way, the parties seem  
24 to be close on numbers, but how those numbers are derived is the issue.

26 Based upon communications with Staff, the Company is working to set a meeting  
27 early next week to resolve all issues. At that meeting, the parties will either settle the

1 matter or move forward with litigation. If a settlement is reached, the parties will submit  
2 a new schedule for adoption of the settlement. Otherwise, the litigation schedule will  
3 govern.

5 Accordingly, the Company requests that the court issue a procedural order  
6 vacating the settlement schedule with the understanding that the parties will submit a  
7 proposed schedule on or before October 14, 2015, if a settlement is reached. The  
8 Company respectfully requests that the October 14, 2015 hearing date be maintained to  
9 address scheduling with the court so that any conflicts with the court's calendar may be  
10 addressed.
