Sulphur Springs Valley Electric Cooperative, Inc. ("SSVEC" or the "Cooperative"), through counsel undersigned, and pursuant to Arizona Administrative Code R14-3-105, hereby moves the Arizona Corporation Commission ("Commission") for an order allowing SSVEC to intervene in the above-captioned proceeding. In support of its application, the Cooperative states as follows:

1. SSVEC is a member-owned non-profit cooperative providing electric service to approximately 51,000 customers in parts of the Arizona counties of Cochise, Santa Cruz, Pima and Graham.

2. The important policy decisions and/or orders the Commission makes in this proceeding will likely effect SSVEC and its member-owners. Thus, SSVEC will be directly and substantially affected by the proceeding.

3. SSVEC's participation in the proceeding will not unduly broaden the issues presented.

4. No other party can represent SSVEC's interests in this proceeding.


