On October 8, 2015, Johnson Utilities, L.L.C. ("Johnson Utilities" or "Company") filed with the Arizona Corporation Commission ("Commission") its proposed Central Arizona Groundwater Replenishment District ("CAGR") adjustor fees for the Phoenix and Pinal Active Management Areas. Pursuant to Decision 71854, as modified by Decision 73284, Johnson Utilities must submit by October 25 of each year, for the Commission's consideration, the Company's updated CAGR fees for the next twelve-month period to apply to all water sold after December 1. Utilities Division Staff ("Staff") has notified the Company that it will need additional to process the October 8, 2015 filing and that it cannot have a Staff Report and Proposed Order ready in time for the updated CAGR fees to be effective on December 1, 2015. Staff has informed the Company that it will have a Staff Report and Proposed Order docketed for consideration at the Commission's March 2-3, 2016 Open Meeting. Johnson Utilities does not object to Staff's requested extension.
