BY THE COMMISSION:

On October 23, 2015, Trico Electric Cooperative, Inc. ("Trico" or "Company") filed an Application with the Arizona Corporation Commission ("Commission") for a rate increase.

On November 3, 2015, the Freeport Minerals Corporation ("Freeport") and Arizonans for Electric Choice and Competition ("AECC") filed a joint Application for Leave to Intervene in this docket.

Freeport is a user of Trico's electric services. AECC is a coalition of energy consumers, most of whom are also customers of Trico.

There were no objections filed to the intervention application.

IT IS THEREFORE ORDERED that **intervention is granted to Freeport and AECC.**
