FOR LEAVE TO INTERVENE**

22 Pursuant to A.C.C. Rule R14-3-105, Pima County, a corporate of the State of  
23 Arizona and body politic, hereby applies to the Arizona Corporation Commission (the  
24 "Commission") for leave to intervene in the above-captioned proceeding.

25 Pima County owns and operates numerous facilities within the Tucson Electric  
26 Power ("TEP") service area which receive electrical service from that utility. Some of

1 these facilities include power generating solar arrays. Pima County will be directly and  
2 substantially affected by this proceeding.

3 Pima County's participation in this proceeding will not unduly broaden the issues  
4 nor will it unduly delay the proceeding except upon leave of the Commission first had  
5 and received.

6 For the reasons provided above, Pima County hereby respectfully requests that the  
7 Commission grant Pima County's Application for Leave to Intervene in this matter.


