**BY THE COMMISSION:**

On July 1, 2015, UNS Electric, Inc. ("UNS" or "Company") filed with the Arizona Corporation Commission ("Commission") its 2016 Renewable Standard and Tariff ("REST") Implementation Plan.

On November 19, 2015, the Energy Freedom Coalition of America ("EFCA") filed an Application for Leave to Intervene. EFCA is a solar energy advocacy association, whose membership is comprised of solar companies including Silevo, Inc., SolarCity Corporation, ZEP Solar, LLC and NRG Energy, Inc. EFCA asserts that it and its members are directly and substantially affected by the outcome of this docket and that EFCA's intervention will not unduly broaden the issues.

On November 24, 2015, The Commission's Utilities Division ("Staff") filed a Memorandum and Proposed Order for the Commission's consideration.

No objections to EFCA's intervention were received.

IT IS THEREFORE ORDERED that EFCA's **intervention** in this docket is **granted**.
