REQUEST FOR AN EXTENSION OF TIME  
TO FILE STAFF REPORT

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") hereby requests an extension of time to file its Staff Report.

On September 17, 2015 Staff filed a sufficiency letter for Los Cerros Water Company Inc.'s ("Company") application for an increase in rates. Staff indicated that it would file its Staff Report on or before December 2, 2015. However, the Staff analyst assigned to this matter left the Commission very recently, resulting in an unexpected delay in the completion of the Staff Report. Staff now finds it necessary to request a brief extension of time for filing the Staff Report.

Therefore, in order to have sufficient time to prepare and file its Staff Report, Staff requests that the filing date for the Staff Report be extended to December 16, 2015. This brief extension will allow Staff sufficient time to properly prepare and file the report.

The Company is not represented by counsel in this matter. On December 1, 2015 Staff counsel undersigned discussed with the Company's corporate secretary, who filed and is prosecuting the Company's application, Staff's plans to request an extension of time, as discussed herein. Based on the discussion with the Corporate Secretary Staff is authorized to say that the Company does not object to Staff's request for an extension of time to December 16, 2015 to file its Staff Report.


