PROCEDURAL ORDER
(Administrative Closure)

BY THE COMMISSION:

On April 2, 2015, Mitel Cloud Services, Inc., ("Mitel" or "Company") filed with the Arizona Corporation Commission ("Commission") a notice that Mitel Cloud Services, Inc. f/k/a Mitel NetSolutions, Inc. would begin providing resold Interconnected and Nomadic Voice-Over-Internet-Protocol ("VOIP") services throughout the State of Arizona.¹ Mitel's filing in this docket updates its tariffs to reflect its additional services and its new name Mitel Cloud Services, Inc.

On November 13, 2015, the Commission's Utilities Division ("Staff") filed a Memorandum stating that the Company's notice does not require Commission action and that Staff recommends the above-captioned docket be administratively closed.

Staff's request is reasonable and should be approved.

IT IS THEREFORE ORDERED that Docket No. T-02585A-15-0112 is hereby administratively closed.


