EPCOR Water Arizona, Inc. ("Company") hereby files its CAP Expense Recovery Surcharge for 2016 for the Paradise Valley Water District, as authorized by the Commission in Decision No. 59079 (May 5, 1995) and Decision No. 61831 (July 20, 1999). The Company is authorized to recover \$118,436 over twenty-five years (ending 2020) via a once a year surcharge applicable to all customer billings in January of each year. The annual recovery amount is \$4,737.44 (\$118,436/25 years). The current surcharge rate for 2015 is \$0.97 per customer based on the prior year end customer count of 4,880 Paradise Valley Water District customers. In performing this year's annual reconciliation, the customer count as of November 30, 2015 was 4,903 resulting in a similar \$0.97 surcharge rate per customer. Therefore, no revision to the current rate of \$0.97 is warranted.

This annual surcharge rate will appear on customers' bills in the January 2016 billing cycle.


