PROCEDURAL ORDER

BY THE COMMISSION:

On July 8, 2015, Tacna Water Management Company ("Tacna" or "Company") filed an application with the Arizona Corporation Commission ("Commission") for a rate increase.

On October 8, 2015, the Commission's Utilities Division ("Staff") docketed its Letter of Sufficiency stating that the Company's application met the requirements of Arizona Administrative Code ("A.A.C.") R14-2-103, and classifying Tacna as a Class E Utility.

On December 4, 2015, Staff filed a Request for an Extension of Time to File Staff Report. Staff requested that, due to the complexity of the issues in the matter, Staff be given until February 1, 2016, to file the Staff Report. Staff noted it had contacted the Interim Manager for the Company about the extension and Tacna had no objection.

IT IS THEREFORE ORDERED that Staff's Request for an Extension of Time to File Staff Report is granted.

IT IS FURTHER ORDERED that Staff shall docket its **Staff Report no later than February 1, 2016.**


IT IS FURTHER ORDERED that the **time clock in this matter is extended to April 29, 2016.**

IT IS FURTHER ORDERED that the *Ex Parte* Rule (A.A.C. R14-3-113 - Unauthorized Communications) applies to this proceeding and shall remain in effect until the Commission's Decision in this matter is final and non-appealable.

IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules of the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission *pro hac vice*.

2 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
3 hearing.
