PROCEDURAL ORDER
(Grants Intervention)

BY THE COMMISSION:

On July 1, 2015, Arizona Public Service Company ("APS") filed with the Commission in this docket a request for approval of its 2016 Renewable Energy Standard Implementation Plan.

On August 27, 2015, APS filed a Notice of Withdrawal of Request for Revisions to Rate Rider Schedule LFCR-DG.

On September 11, 2015, the Arizona Solar Deployment Alliance ("ASDA") filed an Application for Leave to Intervene.

On September 22, 2015, ASDA was granted intervention.

On October 5, 2015, the Residential Utility Consumer Office ("RUCO") filed an Application to Intervene.

On October 14, 2015, RUCO was granted intervention.

On November 19, 2015, The Energy Freedom Coalition of America ("EFCA") filed an Application for Leave to Intervene.

On November 24, 2015, the Commission's Utilities Division ("Staff") filed a Proposed Order.

On December 3, 2015, APS filed a Response to the Recommended Order.

On December 4, 2015, Staff filed a proposed Amendment to the Recommended Order.


No objections to the intervention request have been filed. Accordingly, EFCA should be granted intervention.


