PROCEDURAL ORDER
CORRECTING DEADLINE DATES

BY THE COMMISSION:

On August 18, 2015, Los Cerros Water Company, Inc. ("Los Cerros" or "Company") filed an application with the Arizona Corporation Commission ("Commission") for a rate increase.

On September 17, 2015, the Commission's Utilities Division ("Staff") docketed its Letter of Sufficiency stating that the Company's application met the requirements of Arizona Administrative Code ("A.A.C.") R14-2-103, and classifying Los Cerros as a Class D Utility.¹

On December 1, 2015, Staff filed a Request for an Extension of Time to File Staff Report. Staff requested that, due to staffing issues, Staff be given until December 16, 2015, to file the Staff Report. Staff noted it had contacted the Company about the extension and Los Cerros had no objection.

A Procedural Order docketed on December 7, 2015, granted Staff's Request and extended the time clock, but the Procedural Order contained typographical errors regarding the filing dates and the time clock deadline.

IT IS THEREFORE ORDERED that Staff's Request for an Extension of Time to File Staff Report is granted.

IT IS FURTHER ORDERED that Staff shall docket its **Staff Report no later than December 16, 2015.**

IT IS FURTHER ORDERED the **time clock in this matter shall be extended to April 29, 2016.**


¹ Staff's Sufficiency Letter indicated that a Commission Decision should be rendered on or before May 2, 2016. Based on A.A.C. R14-2-103, the original deadline for the issuance of a Commission Decision for Los Cerros, as a Class D Utility, is March 15, 2016.

1 IT IS FURTHER ORDERED that the *Ex Parte* Rule (A.A.C. R14-3-113 - Unauthorized
2 Communications) applies to this proceeding and shall remain in effect until the Commission's Decision
3 in this matter is final and non-appealable.

4 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules of
5 the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission *pro hac*
6 *vice*.

7 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or
8 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
9 hearing.
