CORNMAN TWEEDY 560'S REQUEST
TO REVISE PROCEDURAL
SCHEDULE

Cornman Tweedy 560, LLC ("Cornman tweedy") hereby requests two revisions to the current procedural schedule in this docket. In her procedural order dated December 9, 2015, the administrative law judge ("ALJ") ordered that (1) Cornman Tweedy file rejoinder testimony and associated exhibits to be presented at hearing by January 28, 2016, and (2) Cornman Tweedy, Arizona Water Company ("AWC"), and Utilities Division Staff ("Staff") make a filing by January 28, 2016, that: (i) specifically identifies the pre-filed testimony, or portions thereof, that the party intends to use at hearing in this stage of this matter; (ii) specifically identifies the previously admitted evidence in this matter upon which the party intends to rely to support its position in this stage of this matter; and (iii) provides any updates and substantive corrections to the pre-filed testimony and evidence. In a subsequent procedural order dated January 5, 2016, the ALJ ordered that AWC file any testimony and associated exhibits responding to Staff's January 6, 2016, direct testimony by January 28, 2016. Due to counsel's current workload and the fact that one of Cornman Tweedy's witnesses providing testimony has been out of town, Cornman Tweedy requests that the deadline for all filings currently due on January 28, 2016, be extended for all parties to Monday, February 1, 2016. No party will be prejudiced by the requested revision to the procedural schedule. Counsel undersigned has informed counsel for AWC and Staff of these requested revisions to the procedural schedule and neither has any objection.


