NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On November 5, 2015, Tucson Electric Power Company (“TEP” or Company”) filed an Application with the Arizona Corporation Commission (“Commission”) for a rate increase.

On January 13, 2016, Sierra Club, a national non-profit environmental and conservation organization, filed a Motion to Intervene in this matter.

On January 13, 2016, the Energy Freedom Coalition of American (“EFCA”) filed an application for Leave to Intervene. EFCA is a solar energy advocacy association whose membership is made up of solar companies.

There has been no objections to the requests to intervene.

IT IS THEREFORE ORDERED that intervention is granted to Sierra Club and EFCA.¹


