STAFF'S NOTICE OF ERRATA

IN THE MATTER OF THE APPLICATION OF SAHUARITA WATER COMPANY, LLC, FOR A DETERMINATION OF THE CURRENT FAIR VALUE OF ITS UTILITY PROPERTY AND FOR THE ESTABLISHMENT OF JUST AND REASONABLE RATES AND CHARGES.

On January 15, 2016, the Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") filed its Notice of Filing Direct Testimony ("Notice") of Staff witnesses Teresa B. Hunsaker, Crystal S. Brown and Michael Thompson. Subsequent to filing the Notice, Staff determined that typographical errors were present in the testimony of Ms. Brown and Mr. Thompson which errors are noted below.

At page 39, line 12 of Ms. Brown's testimony, "go to how the" should be deleted and replaced with "shows how."

At the end of section 6, *Arsenic Blending Plan*, on the bottom of page 20 of the Engineering Report attached as Exhibit MST-1 to Mr. Thompson's testimony, "December 21, 2015" should be deleted and replaced with "January 11, 2016."
