BY THE COMMISSION:

On July 13, 2015, Brian Rak filed with the Arizona Corporation Commission a Formal Complaint against Johnson Utilities, LLC, alleging that Johnson had shut off Complainant's sewer services without notice, and that sewage had backed up in the Complainant's home causing over \$10,000 in damages. The Complaint requested costs relate to damages to Complainant's home as well as punitive damages for mental distress.


On September 18, 2015, the parties filed a Joint Stipulation to Withdrawal of Complaint and Dismissal with Prejudice. The Stipulation was signed by both parties.

Per the Procedural Order filed September 29, 2015 by Yvette B. Kinsey, Administrative Law Judge, the above-referenced Complaint is dismissed with prejudice. Therefore, this docket is administratively closed.


