Regrettably, we are unable to attend in person the 10am hearing on February 1, 2016 to consider a rate increase for our sewers.
We would like you to know that we strongly oppose the approval of Liberty Utilities (Black Mountain Sewer Corps) application for a rate increase by Liberty Utilities in Docket Nos. SW-02361A-15-0206/15-0207. This increase could potentially change our monthly bill from \$65.42 to \$94.20 without further approval by the ACC. This is nearly a 50% increase. That increase is simply unconscionable given that Winfield Community residents have no alternative for sewer service.

We appreciate your consideration of our request and have every hope that your decision will keep in mind homeowners who are on fixed incomes.
