Application for a rate increase by Liberty Utilities

Commissioners:

I hereby wish to submit a formal opposition to the proposed rate increase requested by Liberty Utilities for sewer services to the North Scottsdale areas. Liberty Utilities current rates are now nearly 300% greater than those of the other homeowners of the City of Scottsdale. Liberty Utilities (Black Mountain Sewer Corp) has applied to the Arizona Corporation Commission to raise sewer rates from the current monthly bill of \$65.42 to \$79.20, plus adding a monthly surcharge of \$8.57, bringing the total monthly sewer bill to \$87.77.

If approved, the monthly surcharge could be increased over time to a cap of \$15/month without further approval by the Commission, resulting in a future total monthly bill of \$94.20. I vehemently oppose this application, Docket No. SW-02361A-15-0206/15-0207. Liberty Utilities (Black Mountain Sewer Corp) has
