RE: **ADMINISTRATIVE CLOSURE: RANCHEROS BONITOS WATER CO., L.L.C. – APPLICATION FOR TRANSFER OF CERTIFICATE OF CONVENIENCE AND NECESSITY (CC&N) DOCKET NOS. W-20933A-15-0235 AND W-03254A-15-0235**

On July 1, 2015, Rancheros Bonitos Water Company, LLC (“Rancheros” or “Limited Liability Company” or “L.L.C”) filed with the Arizona Corporation Commission (“Commission” or “ACC”) an application to transfer its Certificate of Convenience and Necessity to Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company. The application noted that the management company would be Sunstate Environmental Services.

When the application was docketed, Sunstate Environmental Services was inadvertently listed as the potential transferee, rather than Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company.

On July 31, 2015, the Commission Utilities Division (“Staff”) filed an Insufficiency Letter, indicating that the Company’s application did not meet the sufficiency requirements of the Arizona Administrative Code (“A.A.C.”) R-14-2-402.

On August 7, 2015, Rancheros filed its response to the Insufficiency Letter.

On August 17, 2015, the parties requested that the docket be corrected to accurately reflect Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company as the transferee/applicant.

On September 15, 2015, by a Procedural Order, the Administrative Law Judge ordered this docket be corrected to remove Sunstate Environmental Services as the transferee/applicant and add Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company as the transferee/applicant.

Ms. Nancy Miller, a Representative of the L.L.C, conferred with Staff and clarified that the purpose of the application is to change the ownership of the Limited Liability Company. Following the meeting with Staff, Rancheros filed two Amendments to its Article of Organization (“Amendments”) with the ACC Corporation Division. On December 1, 2015, and January 7, 2016, the ACC Corporation Division notified the L.L.C. that the Amendments has been approved. The Amendments transferred the ownership of Rancheros from Donald D. Scarbrough and John R. Scarbrough to Richard Miller and Nancy Miller.

On January 20, 2016, Rancheros filed a letter in this docket requesting to withdraw the application, since the ownership transfer has been accomplished.
