**AEPCO COMMENTS ON STAFF
REPORT**

Arizona Electric Power Cooperative, Inc. ("AEPCO" or the "Cooperative") has reviewed the Report filed by Utilities Division Staff ("Staff") in this docket on January 25, 2016. AEPCO appreciates Staff's prompt and thorough analysis of its application. The Cooperative noted one minor typographical error in Staff's Report. In the first paragraph on page 2, Staff references the Commission's approval of AEPCO's two lines of credit "not to exceed the combined amount of \$10,000,000." To clarify, Decision No. 74447 authorized the Cooperative to borrow up to a combined amount of \$100,000,000.

Accordingly, AEPCO respectfully requests that the Administrative Law Judge prepare a Recommended Order adopting Staff's analysis and recommendation consistent with the clarification provided herein.


