PROCEDURAL ORDER

BY THE COMMISSION:

On July 1, 2015, Rancheros Bonitos Water Company, LLC filed with the Arizona Corporation Commission ("Commission") an application to transfer its Certificate of Convenience and Necessity to Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company. The application noted that the management company would be Sunstate Environmental Services.

When the application was docketed, Sunstate Environmental Services was inadvertently listed as the potential transferee, rather than Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company.

On August 17, 2015, the parties requested that the docket be corrected to accurately reflect Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company as the transferee/applicant.

A Procedural Order issued September 15, 2015, corrected the docket to remove Sunstate Environmental Services as the transferee/applicant and add Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company as the transferee/applicant.

On January 20, 2016, the transferee/applicant filed a letter requesting that the Application be withdrawn. The transferee/applicant stated that ownership of Rancheros Bonitos Water Company, LLC had been transferred to Richard and Nancy Miller by means of Articles of Amendment approved by the Commission's Corporation Division on December 1, 2015.

The Commission's Utilities Division ("Staff") has not responded to the Request.

1 IT IS THEREFORE ORDERED that Staff shall docket its response to the Request to
2 Withdraw Application, specifically addressing the applicability of A.R.S § 40-285, no later than
3 February 19, 2016.

4 IT IS FURTHER ORDERED that the *Ex Parte* Rule (A.A.C. R14-3-113 - Unauthorized
5 Communications) applies to this proceeding and shall remain in effect until the Commission's Decision
6 in this matter is final and non-appealable.

7 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules of
8 the Arizona Supreme Court and A.R.S. § 40-243 with respect to practice of law and admission *pro hac*
9 *vice*.

10 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or
11 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
12 hearing.
