PROCEDURAL ORDER
(Administratively Closing Docket)

BY THE COMMISSION:

On July 1, 2015, Rancheros Bonitos Water Company, LLC ("RBWC" or "LLC") filed with the Arizona Corporation Commission ("Commission") an application to transfer its Certificate of Convenience and Necessity ("CC&N") to Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company ("Application"). The application noted that the management company would be Sunstate Environmental Services.

When the Application was docketed, Sunstate Environmental Services was inadvertently listed as the potential transferee, rather than Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company.

On August 17, 2015, the parties requested that the docket be corrected to accurately reflect Richard and Nancy Miller, d/b/a Rancheros Bonitos Water Company as the transferee/applicant.

A Procedural Order issued September 15, 2015, corrected the docket to remove Sunstate Environmental Services as the transferee/applicant and add Richard and Nancy Miller d/b/a Rancheros Bonitos Water Company as the transferee/applicant.

On January 20, 2016, the transferee/applicant docketed a letter requesting that the Application be withdrawn. The letter stated that the ownership of the LLC had been transferred from its present owners, Donald D. Scarbrough and John Scarbrough, to Richard and Nancy Miller through two Articles of Amendment filed with the Commission's Corporation Division, and approved on January 7, 2016.

1 On February 2, 2016, the Commission's Utilities Division ("Staff") docketed a Memorandum
2 requesting administrative closure of the docket. Staff indicated it had discussed the matter with Nancy
3 Miller, and Ms. Miller clarified that the purpose of the Application is to change the ownership of the
4 LLC; not to transfer the CC&N to a new entity. After meeting with Staff, RBWC filed the two
5 Amendments to its Articles of Organization.

6 Although Staff docketed its Memorandum on February 2, 2016, the Administrative Law Judge
7 did not receive it until February 8, 2016. As such, a Procedural Order was issued on February 5, 2016,
8 directing Staff to file a response to the withdrawal request no later than February 19, 2016.

9 Having reviewed Staff's Memorandum, Staff's recommendation should be adopted and the
10 February 19, 2016, filing deadline should be vacated.

11 IT IS THEREFORE ORDERED that **Docket Nos. W-03254A-15-0235 and W-20933A-15-**
12 **0235**, In the Matter of the Application of Rancheros Bonitos Water Company, LLC for a transfer of
13 Certificate of Convenience and Necessity to Richard and Nancy Miller, are **administratively closed**.

14 IT IS FURTHER ORDERED that the **filing deadline for Staff's response to the withdrawal**
15 **request is vacated**.


