**STAFF'S REQUEST FOR AN EXTENSION
TO FILE SURREBUTTAL TESTIMONY**

On May 5, 2015, UNS Electric, Inc. ("UNSE" or "Company") filed an Application with the Arizona Corporation Commission ("Commission") for a rate increase.

On June 22, 2015, the Hearing Division issued a Rate Case Procedural Order and Notification of Intervention ("Procedural Order") which established a procedural schedule for this case. Under the Procedural Order, the Surrebuttal testimony of the Commission's Utilities Division ("Staff") and all intervenors is due February 19, 2016. The Company's Rejoinder testimony is due February 26, 2016.


Due to extensive work-related, out of state travel obligations of Staff's Director and Assistant Director, as well as the unavailability of its Assistant Chief Counsel due to a death in the family, Staff requires additional time to complete its Surrebuttal testimony. As a result, Staff hereby requests a brief extension until Tuesday, February 23, 2016, at 12:00 p.m. in which to file its Surrebuttal testimony.

Staff would not object to any intervenor herein having a similar extension for their Surrebuttal. In addition, Staff would not object to extending UNSE's date for filing Rejoinder testimony to Monday, February 29, 2016 at 4:00 p.m.

1 Staff has conferred with the Company's counsel who advised that UNSE has no objection to
2 Staff's request for an extension of time and to the extension applying to all other parties filing
3 testimony on February 19, 2016. Staff has also sent an email to all parties advising of the filing of
4 this request.

5 Wherefore, Staff respectfully requests a short extension of time to February 23, 2016, at 12:00
6 p.m. to file Surrebuttal testimony in this case
