**STIPULATED MOTION TO AMEND  
CASE SCHEDULE**

19 The Arizona Corporation Commission Staff ("Staff") and Picacho Peak Water  
20 Company, Inc. ("Company") hereby move this Court to amend the case schedule in this  
21 matter. The parties request the Court issue a procedural order allowing Staff to file a  
22 revised Staff Report on or before March 4, 2016, and allowing the Company to file  
23 comments regarding the Staff Report on or before March 18, 2016.

26 The parties make this request to give Staff adequate time to address certain matters  
27 identified by the Company in its initial review of the Staff Report. After Staff files the  
28 revised report, the Company will need ten business days to review the document, then

1 draft and file its comments. The parties believe this approach will narrow the issues and  
2 avoid the need for additional filings, which would prolong this case. Therefore the  
3 parties move the Court to issue an order allowing Staff to file a revised Staff Report on or  
4 before March 4, 2016, and allowing the Company to file its comments on or before  
5 March 18, 2016.


