
The City of Globe and Arizona Water Company (collectively the "Parties") report that a settlement agreement has not yet been signed but the Parties are still working toward settlement. As discussed in the February 12, 2016 Status Report, the settlement agreement was discussed at the Globe City Council meeting of February 23, 2016. The item was tabled in order for the Parties to continue working on the language of the settlement agreement. This is occurring and the Parties are still in communication and have a meeting scheduled for February 29, 2016 to discuss and hopefully finalize the terms of the settlement agreement and related agreements that are part of the settlement. The City Council and Arizona Water Company Board will then still need to approve the final form of agreement. The Parties intend to file the settlement agreement once it is signed, along with a joint proposed form of notice of the hearing at which the settlement will be considered by the Commission.

1 Under these circumstances, although everything is progressing towards settlement, in
2 order to give proper notice the March 21, 2016 settlement hearing date should be vacated and
3 continued until the settlement agreement is fully executed. When that step occurs the parties will
4 notify the Commission and seek a continued hearing date so that it may be duly noticed.

5 If the settlement agreement has not been signed by March 25, 2016, the Parties will file
6 an updated Status Report.
