12 On October 23, 2015, Trico Electric Cooperative, Inc. (“Trico” or “Company”) filed an
13 Application with the Arizona Corporation Commission (“Commission”) for a rate increase.

14 On October 6, 2015, by Procedural Order, the matter was set for hearing to commence on July
15 19, 2016, and other procedural guidelines were established.

16 On November 20, 2015, Robert B. Hall, a Trico customer, filed an Application for Leave to
17 Intervene in this docket.

18 By a Procedural Order issued December 3, 2015, Mr. Hall was granted intervention in this
19 matter.

20 On January 20, 2016, Mr. Hall filed a Consent to E-Mail Service.


