On February 24, 2015, the Commission’s Utilities Division (“Staff”) filed a Memorandum opening the above-referenced docket.

On February 26, 2015, Morenci Water and Electric Company (“Morenci”) filed a Demand-Side Management Progress Report.

On February 27, 2015, UNS Electric, Inc. (“UNS”), Trico Electric Cooperative, Inc. (“Trico”), Arizona Public Service Company (“APS”), Mohave Electric Cooperative, Inc. (“Mohave”), and Tucson Electric Power Company (“TEP”) each filed a Demand-Side Management Progress Report.

On February 25, 2016, Staff filed a Memorandum stating the sole purpose for the opening of this docket was for compliance memorandums indicating that the electric providers had filed their required Demand-Side Management Reports for the year 2015.
