Pursuant to A.A.C. R14-3-108(Q), Justin and Heather Billingsley ("Billingsleys"), Jeffrey Peterson, and Loan Go Corporation (hereafter "Respondents"), request a continuance of the hearing currently scheduled for April 4, 2016, along with the additional hearing dates set aside in April for additional hearing days (if needed).

R14-3-108(Q) states that a matter may be continued prior to a hearing on a showing of "good cause" for "submission of further or additional evidence or for any other proper purpose." Eric J. Jeide entered an appearance on behalf of the Billingsleys on February 29, 2016. Mr. Jeide also represents Mr. Peterson and Loan Go Corporation in this matter. Since taking on an additional client

1 will require additional time to adequately prepare for this matter on behalf of the Respondents, both  
2 for the collective interests and any separate but not conflicting interests, "good cause" exists to  
3 continue the hearing date. In addition, Respondents will use the additional time granted to collect  
4 and submit additional evidence supporting its claims.

5 Respondents' counsel spoke with the Securities Division ("Division") via attorney Paul  
6 Kitchin, who stated that the Division would not oppose a motion to continue. The Division requested  
7 the continuance be scheduled for August, if not in conflict with the hearing calendar, based on  
8 scheduling conflicts of other hearings that Mr. Kitchin is handling.

10 Therefore, Respondents hereby **REQUEST** the hearing currently scheduled for April 4, 2016  
11 be continued until the first week of August 2016, or thereabouts.
