RE: IN THE MATTER OF THE COMMISSION ON ITS OWN MOTION INVESTIGATING THE FAILURE OF NUMEROUS UTILITIES TO FILE ANNUAL REPORTS FOR CALENDAR YEAR 2013 (DOCKET NO. C-00000A-15-0118)

On April 28, 2015, Staff filed a Complaint and Petition for Order to Show Cause against various utilities for failure to file their 2013 Utilities Division Annual Report. On October 27, 2015, the Arizona Corporation Commission ("Commission") issued Decision No. 75315 ordering a Complaint and Order to Show Cause ("Complaint" or "OSC") against utilities that remained non-compliant in the filing of said Annual Report. Since the issuance of this Decision, the following utility has filed an application with the Commission requesting approval to cancel its Certificate of Convenience and Necessity.

Accordingly, Staff recommends that the above named utility be dismissed from this Complaint and Order to Show Cause.
