13 The Residential Utility Consumer Office ("RUCO") does not oppose Johnson Utilities,
14 LLC, dba Johnson Utilities Company ("Company") request for an extension to file the
15 Company's 2015 earnings report pursuant to Decision No. 74695. RUCO does not oppose this
16 request for several reasons; (1) the request was submitted in a timely manner, approximately
17 two weeks prior to the February 29, 2016, due date; (2) RUCO understands the complexity
18 involved in closing the accounting books and records for year ending December 31, 2015, and;
19 (3) the Company is required to file a full rate case by June 30, 2016 using at test year ending
