NOTICE OF COMPLIANCE FILING

IN THE MATTER OF THE APPLICATION OF
ARIZONA WINDSONG WATER COMPANY,
TO TRANSFER ASSETS TO NAVAJO TRIBAL
UTILITIES AUTHORITY

The decision approved at the April 12, 2016 open meeting requires Arizona Windsong Water Company ("Windsong") to file "notification that the Navajo Tribal Utility Authority is providing water service to the area previously served by Arizona Windsong Water Company no later than thirty (30) days from the date that service began." Windsong provides notice that the Navajo Tribal Utility Authority began providing service on April 20, 2016.

In accordance with the decision, upon the filing of this notice, "Arizona Windsong Water Company's status as a public service corporation in Arizona shall terminate without further order of the Commission." Accordingly, Windsong requests that the Utilities Division remove it from the list of regulated public service corporations, remove the Windsong tariff books, and take other appropriate administrative actions.
