On March 16, 2015, the Commission’s Utilities Division (“Staff”) filed a Memorandum opening the above-referenced docket.

On March 31, 2015, Southwest Gas Corporation (“SWG”) filed its Arizona Energy Efficiency and Renewable Energy Resource Technology Portfolio Implementation Plan.

On April 1, 2015, UNS Gas, Inc. (“UNSG”) filed its Demand-Side Management Report.

On September 30, 2015, SWG filed its Arizona Energy Efficiency and Renewable Energy Resource Technology Portfolio Implementation Plan Annual Status Report.

On October 1, 2015, UNSG filed its annual Demand-Side Management status report.

On March 17, 2016, Staff filed a Memorandum stating the sole purpose for the opening of this docket was for compliance memorandums, indicating that the gas providers had filed their required Demand-Side Management Reports for the year 2015, and requesting that this docket be administratively closed.
