PROCEDURAL ORDER

BY THE COMMISSION:

On February 12, 2016, IM Telecom, LLC d/b/a Infniti Mobile (“Infniti”) filed with the Arizona Corporation Commission (“Commission”) an application for designation as an Eligible Telecommunications Carrier in the State of Arizona on a wireless basis (Low-Income Only).

On March 4, 2016, the Arizona Local Exchange Carriers Association (“ALECA”) filed a Motion to Intervene in the above-captioned proceeding. No objections to ALECA’s motion have been filed.

There being no objection, and good cause appearing, ALECA’s motion should be granted.

IT IS THEREFORE ORDERED that the Arizona Local Exchange Carriers Association is hereby granted leave to intervene in the above-captioned proceeding.

IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules 31, 38, 42 and A.R.S. § 40-243 with respect to practice of law and admission pro hac vice.

IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Arizona Supreme Court Rule 42). Representation before the Commission includes the obligation to appear at all hearings and procedural conferences, as well as all Open Meetings for which the matter is scheduled for discussion, unless counsel has previously been granted permission to withdraw by the Administrative Law Judge or the Commission.

1 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or
2 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
3 hearing.
