

1. My name is Elaine M. Divelbliss. I am employed by Virgin Mobile USA, L.P. ("Virgin Mobile" or "Company") in the position of Senior Counsel, Government Affairs. In this position I am personally familiar with the Federal Universal Service support received by the Company and how the Company uses these funds.

2. Virgin Mobile was designated as an eligible telecommunications carrier ("ETC") by the Arizona Corporation Commission in Docket No. T-2087A-11-0461, Decision No. 73664 (February 6, 2013).

3. The Lifeline discounts or equivalent provided by Virgin Mobile are equal to the amount of total Federal Universal Service Fund Support received per line.
